Cities & Ports

Valkenburg

Enjoy 2-nights in Valkenburg, a traditional Dutch village along the banks of the Geul River, just 8 miles east of Maastricht. The village was so famous for its beauty and wealth that it had been fought over for hundreds of years. From here enjoy a **Three Country Tour** featuring Monschau, Germany, the Henri Chapelle Cemetery in Belgium & the oldest town in the Netherlands, Maastricht.

Amsterdam

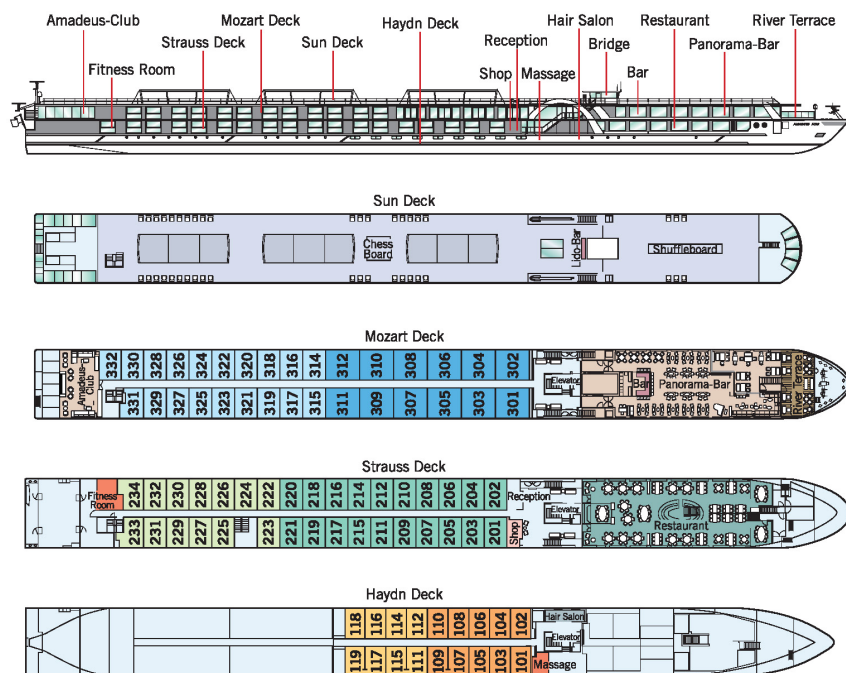
