#### B. <u>HIGH SCHOOL COMPLETION STATUS</u>

Students must provide one of the following documents to the Admissions Office that indicate the student's high school completion status when the student will begin college in 2018–2019.

- A copy of the high school diploma or a copy of the final official high school transcript that shows the date when the diploma was awarded.
- A copy of the student's General Educational Development (GED) certificate or GED transcript or recognized equivalent of a HS diploma.

□ An official academic transcript of a student who has successfully completed at least a two-year program that is acceptable for full credit toward a bachelor's degree, or

□ Student excelled academically in HS and has met all the criteria to be admitted to a 2-year degree program or higher-must submit official documentation.

Note: If student completed high school as homeschooled, a transcript or the equivalent, signed by the parent or guardian, that lists the secondary school courses the student completed and documents the successful completion of a secondary school education in a homeschool setting must be submitted to the Admissions Office for evaluation. The student will not be eligible for financial aid if the Admissions Office determines that the school or transcript is not valid or the equivalent of a high school diploma.

#### C. IDENTITY AND STATEMENT OF EDUCATIONAL PURPOSE

#### IMPORTANT: To Be Signed at the Institution

The student must appear in person at <u>COLLEGE OF THE MAINLAND</u> to verify his or her identity by presenting a valid government-issued photo identification (ID), non-expired such as, but not limited to, a driver's license, other state-issued ID, or passport.

The institution will maintain a copy of the student's photo ID that is annotated with the date it was received and the name of the official at the institution authorized to collect the student's ID. In addition, the student must sign, in the presence of the institutional official, the following:
