About the Application Process

Step 1: Apply to the college (http://www.com.edu/admissions/apply)

- Submit official transcripts and a Transcript Evaluation Form to COM Admissions Department for all colleges attended (except COM)
- Allow at least 2 weeks for the evaluation to be completed (allow 2-3 months during peak times)
- All transferred courses must be in the Student Information System (SIS) to be eligible for admission to nursing

Step 2: Meet with an academic advisor in the Student Success Center

- Select the part-time ADN pre-licensure nursing program and track
- Review the pre-nursing academic plan
- The nursing application link will be visible in WebAdvisor after this meeting, but will not be accessible until after completing Step 3

Step 3: Meet all eligibility requirements for application to the ADN Program Pre-Licensure Track

Step 4: Apply for admission in WebAdvisor by 1700 (5 p.m.) on the desired deadline date

★When all eligibility requirements are met, the nursing application link will be accessible in WebAdvisor.

Fall Admission – May 15th

Applicants are ranked for selection based on the following:

- *Weighted GPA for prerequisite courses
- *Science Points
- *Education Points (Master's Degree, Bachelor's Degree, Associate's Degree, Health-Related Certificates)
- Check "Application Updates" on the ADN Program Pre-Licensure Track webpage during the selection process
- Login to WebAdvisor to track your application status during the selection process
- ALL communication from the Nursing Department will be sent to your official COM email address

Step 5: Get electronic copies of these documents ready for upload if accepted for admission

Immunization record(s) showing proof of:
☐ Hepatitis B Virus (HBV) positive titer (The series of three injections normally takes 7 months to complete.)
☐ Measles, mumps and rubella <u>positive</u> titers
□ Varicella (chicken pox) positive titer
☐ Influenza (flu) immunization for current flu season
☐ Current combined Tetanus , Diphtheria and Pertussis (Tdap) immunization within the past 10 years (Td alone is not
acceptable.)

Notice to Students Regarding Licensing

Effective September 1, 2017, HB 1508 amends the Texas Occupations Code Section 53 that requires education providers to notify potential or enrolled students that a criminal history may make them ineligible for an occupational license upon program completion. This information is being provided to all persons who apply or enroll in the program, with notice of the requirements as described above, regardless of whether or not the person has been convicted of a criminal offense. Additionally, HB 1508 authorizes licensing agencies to require reimbursements when a student fails to receive the required notice.
