Dr. Nichols,

As we are both aware, because of COVID-19 our Summer 2020 enrollment numbers are disappointing. We are anticipating a short fall in our tuition revenues that are materially and significantly below our budgeted expectations. While I know we stated publicly and we are truly making every effort to not adversely affect any of our employees during this crisis, financial realities require us to address the situation at hand. I have been reviewing the college's finance and budget documents to identify strategies to keep our expenses below our revenues and not produce a deficit for the 2019-2020 fiscal year. Tops among the options I have explored include recommending reducing our workforce by declaring financial exigency.

However, I believe the \$883,942 recently awarded to the college from the Federal Government from the CARES Act allows the institution's administration to postpone, and possibly cancel the necessity of implementing such action.

Simply restated, but for the CARES Act money we would have to furlough employees and possibly declare financial exigency. Please give me your thoughts on the recommendation of using CARES Act funds to not reduce our workforce.

I shall continue to monitor our financial situation and provide you with updated information as it becomes available.

Dr. Nichols,

Let me add additional clarification and context to the memo I sent on April 29, 2020. I want to clarify that the shortfall that would have occurred this past spring was the direct result of the COVID-19 virus and its impact on our revenues. Again, the impacts of the COVID-19 virus would have required the College of the Mainland to furlough and lay off employees and possibly declare financial exigency. The \$883,942 awarded to the college from the Federal Government from the CARES Act allowed the institution's administration to postpone, and possibly cancel the necessity of implementing such adverse financial actions to our employees because of the COVID-19 virus.

I shall continue to monitor our financial situation and provide you with updated information as it becomes available.
