RESOLUTION AND ORDER

ADOPTION OF THE TAX RATE AND LEVYING AD VALOREM TAXES FOR THE YEAR 2019, FOR THE SUPPORT AND MAINTENANCE OF COLLEGE OF THE MAINLAND

WHEREAS, the College of the Mainland has been duly organized in accordance with the laws of the State of Texas; and

WHEREAS, it is necessary that Ad Valorem Taxes be levied for the support and maintenance of the College of the Mainland for the fiscal year 2019-2020, and tax year 2019;

WHEREAS, Tommy Watson of the Galveston County Tax Appraisal District, who serves as the Tax Assessor-Collector for the district has certified and published an effective tax rate for 2019 of \$0.204254 on each one hundred dollars (\$100) of valuation as required by Section 26.04 of the Tax Code; and

WHEREAS, the Board of Trustees of the College of the Mainland in Galveston County, Texas, has determined that the amount of money needed by the District to maintain the same amount of tax revenues, will require a tax levy at the rate of $\frac{$0.204254}{}$ on each one hundred dollars (\$100) of valuation; and

WHEREAS, the Board of Trustees of the College of the Mainland has previously adopted and approved a budget for the 2019-20 fiscal year in compliance with state law; and

WHEREAS, the Board of Trustees of the College of the Mainland has complied with all the procedural requirements for the setting of the 2019 ad valorem tax rate as specified by the Tax Code and Education Code,

NOW, THEREFORE BE IT ORDAINED AND ORDERED by the Board of Trustees of the COLLEGE OF THE MAINLAND that we, the Board of Trustees of the College of the Mainland, do hereby levy or adopt the rate on \$100 evaluation for this community college district for the tax year 2019 as follows:

<u>\$ 0</u>	for the payment of principal and interest on debt of this college district
\$0.204254	Total tax rate

BE IT FURTHER ORDERED that, upon the adoption of this Resolution and Order, the Secretary of the Board of Trustees of the College of the Mainland shall certify to a copy of this Resolution and the minute order adopting same, and forward to both the Assessor and Collector of Taxes.

This Resolution and Order shall take effect from and immediately upon its adoption.
