- Apply and be accepted to a **Texas public** college or university of his/her choice. Go to <u>www.applytexas.org</u> to apply or use your College of the Mainland's application for admissions.
- 2. Provide proof (DD214) from the Department of Defense regarding military service and the nature of discharge.
- 3. Provide proof of eligibility or ineligibility for GI Bill benefits (Chapter 31, 33/Post-9/11) by requesting a certificate of eligibility for federal education benefits <u>online here</u> (if the Veteran does not have active duty service after 9/11/2001 skip this step)
- 4. Fill out the <u>Hazlewood Exemption application form</u>; and print out.

Printout page verifying number of Hazlewood Exemption Hours used (even if it indicates zero).
- Submit the completed Request for Certification Packet to <u>COMVETS@COM.EDU</u> by providing the following documents. Forms must be filled in - *no blank sections*. Incomplete packets will be rejected.
 - 1. Hazlewood Exemption application
 - 2. a copy of your letter of eligibility/ineligibility for Post 911 benefits
 - 3. a copy of your DD214
 - 4. Veteran Transcript Evaluation Request form
 - Printed copy of your registration and fee payment schedule. (after you have registered for your classes). Go to WebAdvisor > located under Registration, then click on Fee Statement and Schedule
 - 6. Printout verification page from the Texas Veterans Commission Website (Hazlewood Exemption) verifying the number of Hazlewood hours used or showing zero hours used.
